Notes on Sliding Fee Scale:

Adjusted Gross Income is your total gross income listed on form 1040 line 11 of your tax return. If using a paycheck, it is gross wages minus any Health Savings Account contributions

Household is defined as who can be included on a joint tax return or who would be eligible to be included as a dependant on a tax return.

Nominal fee not to exceed \$20 for applicable services.

Full fees will be applied until Financial Information is provided.

Hardship Applications are available but must be completed and submitted to be eligible for discounts on the sliding fee scale.

Clients not residing in Cherokee County, Kansas will be assessed a fee at the full rate.
